The 62nd Annual Lisburn Community Fire Company Festival will be held on Wednesday thru Saturday, August 5th, 6th, 7th and 8th, 2015. Once again we are inviting vendors and non-profit organizations to participate with us at the area's largest firefighter's carnival.

On the next page is the registration form. Please list your preference of spaces from 1st to 3rd. The spaces and exclusive offering of your particular product will be assigned on a first-come, first-served basis. You will also find enclosed a map with available spaces at this time. We are able to add new spaces for 2015, depending on requests.

- Your rental fee **MUST** be included with your registration to reserve your space. If both are received by July 15th, 2015 you may deduct 10% from your cost. This will also ensure your desired space and exclusive offering of your particular product. In order to make your experience better and assist us to prepare better, we may not be able to guarantee your space unless your registration and check are received before July 25th.
- Codes regarding electrical lines will be enforced. All cords must be off the ground and covered. We will aid all vendors to assist in meeting this requirement.
- Set-up time may begin Monday, August 3rd, **WITH NOTICE**. Please contact Elaine Cady @ 717-620-8486 (home) or 717-855-5249 (cell) for set-up times or questions.
- Silly String and bomb bags are prohibited from being sold.
- Please note that this year's Festival again is a four (4) day event. Wednesday night is a "Ride Night" Arts & Craft vendors will not be affected by Wednesday's program; therefore, you can still setup and prepare for the Thursday thru Saturday event; however all are encouraged to participate in Wednesday's activities.
- All booths must be set up by 4:00 pm Thursday. Vehicles must be moved from the grounds at that time and parked in the designated vendor parking area. Two parking passes will be issued to each vendor.
- Circulars or advertising material may be distributed **ONLY** from the vendor's assigned area and in a manner that will not interfere with other vendors.
- No pets permitted on the Festival grounds at any time.
- The Festival reserves the right to relocate any exhibit and/or make adjustments of space allotments, as it deems necessary for the best interest of the Festival.
- Festival hours are 6:00 -10:00 on Wednesday, 4:00 – 10:00 on Thursday and Friday and 4:00 to 11:00 on Saturday. All Vendors will remain open till the close of Festival each day.
- After your application has been received and processed, you will receive a confirmation letter, two parking passes and a map with your designated space highlighted.
